IMPORTANT NOTE:

- BC legislation requires you to be a current student registrant of CTCMA before you undertake the clinical training.
- All student registrations expire on March 31, 2018. If you are undertaking clinical training in a Traditional Chinese Medicine education program in B.C. after March 31st, you are required to renew your student registration before the expiry date for continuous registration.
- ONLY clinical hours completed during the period your CTCMA student registration is valid will be recognized.
- Please note:
 - If the renewal fee is received between April 1 and June 30, 2018: Additional 35% Reinstatement Fee (= \$70.00) will be required.
 - After June 30, 2018: You must submit a NEW application for Student Registration.
- Application will not be processed until ALL required documents, items and fees are received by the College.
