APPLICANT'S ACKNOWLEDGEMENTS

I, _____, acknowledge that taking the Pan-Canadian Examination before completing and graduating from the required TCM program with the minimum required clinical training hours set out in Schedule E may impact my examination scores in the examination(s) as the entry-level occupational competencies related to clinic instruction might not have been fully acquired and learned in the educational program. I accept the risks and the challenges in order to take the opportunity to participate in the October 2022 examination administrations. I act voluntarily in submitting my exam application for the October 2022 examination.

I am aware that this examination attempt will be counted towards my total number of attempts of taking the examinations.

I understand that, in order to receive provisional approval to write in the October 2022 administration, by the examination deadline:

- I must meet all requirements for the Pan-Canadian Examinations except the required clinical training hours; and
- I have completed or will complete a minimum of 75% of the required clinical hours in my TCM education program by July 15, 2022.
- I can provide **an interim transcript** issued by my school confirming I am in the process of completing the remaining clinical training requirement; and
- My school director/dean/coordinator will provide **a written confirmation** that I meet all the requirements for graduation from the TCM educational program with the exception of the clinical training.

The provisional approval, if granted, is for the October 2022 sitting only. In the event that I fail the October 2022 Pan-Canadian Examinations, a new application to determine meeting the exam eligibility requirements at the time will be required.

I understand that if I am approved to take the exam and pass the exam, I must meet all registration requirements as specified in the College Bylaws, including graduation from a TCM educational program, in order to be considered for registration with the College.

I understand that I must successfully complete the remainder of clinical hours required by the TCM education program in which I am currently enrolled, and I must provide confirmation of completion at the time of registration application.

I have read and understood the above acknowledgements and agree to be bound by them. I further understand that any omission(s) may result in not receiving registration approval.
